### RECREATION MEMBERSHIP SUBSIDY PROGRAM

The Langley Senior Resources Society (LSRS), together with the City of Langley and Township of Langley, is pleased to offer a subsidy for our annual LSRS Recreation Membership to **qualifying seniors residing in the City of Langley and Township of Langley**. We would like to thank the City of Langley and the Township of Langley for their support of this subsidy! This offer is valid until December 31<sup>st</sup>, 2024, or until funds last.

#### **ELIGIBILITY:**

To be eligible for the Recreation Membership Subsidy Program individuals must be:

- ✓ **A resident of the City of Langley or Township of Langley**
- ✓ 50 years of age or older
- ✓ Total income (taxable and non-taxable) less than \$27,000 (single), or \$32,000 (couple)

#### **SUBSIDY AMOUNT:**

The Recreation Membership Subsidy Program is a tiered scale of financial support. The “Basic” Recreation Membership Subsidy qualifies applicants for a full coverage of (or full reimbursement of) the 2024 LSRS Recreation Membership. Applicants may also qualify for an “Advanced” Recreation Membership Subsidy based on total income.

#### **HOW OFTEN CAN I APPLY?**

Each calendar year, eligible candidates can apply. However, candidates must fill out a new application annually and provide new, updated supporting documentation for the application.

#### **APPLICATION PROCESS:**

If you meet the eligibility requirements, please complete the application form (**SEE REVERSE OF SHEET FOR APPLICATION**) and **include the following supporting documentation:**

- **Proof of residency** – you must provide a copy of a recent utility bill or rent receipt that confirms your address.
- **Proof of income** – a copy of your most recent Tax Notice of Assessment provided by Canada Revenue Agency.

Seal your application and supporting documentation in the envelope provided and drop-off your envelope at the Front Desk of the Seniors Centre, 20605 51B Avenue, Langley, BC. Confidentiality will be maintained.

Once your application has been reviewed, you will be contacted by our staff to make arrangements for processing your Recreation Membership. The review process may take up to two weeks.
