- o I see so many activities happening at the Centre, so I would like to have amateurs take photos and submit them to "In the Loop." Anthony answered that members have signed a waiver for photos; however, the photographer should ask people if they want their pictures taken.

- o What is the fiscal year for the AGM report? Anthony answered from April 1 to March 31.
- Why was the AGM held so late this year? Usually, the AGM is held in September, and was
  delayed because the Board needed to wait for our lawyer's comments regarding the
  amendments to the Bylaws.

# Executive Directors Message

Emerging from the pandemic, the Langley Senior Resources Society has experienced significant transition and change. These changes, and all the uncertainties that change brings, caused us to reflect on what really matters as individuals and as a community.

Together, we learned what our new "normal" would be and took the necessary precautions as we carefully restarted our recreation, education, and social programming as well as our much-needed community services. Like many businesses, LSRS faced numerous challenges post-COVID, such as hiring qualified staff, and this placed incredible strain on the organization. With all these changes, our Board felt the time was right to embark on a review of our vision, mission, and values. Through this process, we spoke to our staff, members, volunteers and community partners and your valuable feedback will be woven into our renewed purpose.

Our Adult Day Program, and the clients and families who rely on it, was greatly impacted by the pandemic. This is a critical service that LSRS provides to older adults who have physical and cognitive impairments while also providing important respite for their caregivers – of which many are seniors themselves. We are grateful for the strong partnership we have with Fraser Health who worked closely with us to get all protocols in place to ensure this vulnerable group was as safe as possible, without compromising the integrity of our mission.

We gradually returned to our full slate of Recreation Programs and launched a few new ones including a popular educational speaker series called the Monday Morning Talk Show. We also partnered with Blacklock Fine Arts School on an intergenerational Storytelling and Art project which was displayed at City of Langley Council Chambers. Thanks to our chef and kitchen team, our take-away meals that were so popular during COVID-19 have become part of the regular menu in our Café. During the year, we also made significant investments in the maintenance and repair of the recreation center facility and grounds, and revenue from filming helped with costs.

Our Community Services team was stretched to capacity with a growing number of seniors turning to LSRS for support and services. We embraced a new initiative called social prescribing which enables healthcare providers to refer people to local, non-clinical community and social services, like LSRS. In April, we welcomed Linda Smith, who works closely with our local healthcare providers to assist seniors who need immediate wellness support. Sadly, food insecurity has become an emerging issue, and we were grateful to receive a generous gift of \$10,000 worth of grocery gift cards from a kind LSRS member. With the 2021 heat dome in mind, we worked closely with our municipal partners to ensure seniors in Langley were aware of the dangers of extreme heat, where the designated cooling centers were located and how they could access them. We also were invited by the Langley Division of Family Practice to take part in the

planning for a Primary Care Network in Langley with the goal of developing a model of teambased care where residents who don't have a family doctor can more easily access primary care. Pandemic recovery also challenged our fundraising efforts. Despite this, we saw an increase from our Tuk Shop which raised almost \$40,000 – an amazing accomplishment for our social enterprise powerhouse entirely run by volunteers. We also raised funds for a new footcare clinic chair and were the charitable beneficiary of the Fort Langley Half Marathon – over \$7,500 was contributed and we thank all the volunteers and participants who helped make this a great success. A heartfelt thanks goes to our government partners, community supporters, members, donors, and volunteers for their significant and continued support of our programs and activities.

During the year, we focused our efforts on building strong community partnerships and as a result, LSRS is increasingly seen to be a leader on issues affecting seniors. We are honoured to be part of many local and regional committees, tables, and advisory groups that allow us to assist and advocate for the needs of older adults. Some of our activities included joining the Langley Local Immigration Partnership committee, assisting with the launch of a Langley Men's Shed, and attending the annual Langley Community Walk and ArtsAlive! Festival. We also took part in a research study with Qu Biologics to look at immune function in the elderly – thank you to all LSRS members who participated. Our community partners are important foundations for our work, and we are united in our mutual goal of supporting seniors as best we can.

The common factor throughout 2022 was a continued effort to support vulnerable seniors through programs such as Better at Home, Telephone Buddies, takeaway meals, and social prescribing. We know that society benefits when older adults are healthy, safe, and receive the care they need – when and where they need it. For me, the key word for what really mattered most is gratitude.

Gratitude for those we serve, and their families, who demonstrated patience as we emerged from the pandemic and needed to adjust our operations. Gratitude for our amazing leaders on our Board who helped members and clients understand what and why things were changing. Gratitude for our volunteers and donors who provided unwavering commitment during uncertain times. And gratitude for the leadership everyone has shown in looking out for each other, being empathetic, kind, and offering help in little and big ways.

Finally, our greatest asset is a remarkable team of caring employees who believe in the work they do and are proud to deliver the best possible services to seniors in our community. From the moment I arrived at LSRS, I have witnessed their dedication, and it is a pleasure to work with them. Their passion, commitment, and expertise contributed to the strength of our organization. And LSRS is supported by an incredible volunteer Board of Directors who are steadfast in their commitment to the critically important work of this organization, our employees, and community. Seniors in Langley are well served by all these talented, kind, and compassionate individuals.


### Sherry Tingley - Candidate
